# Civic Center Planning Workshop Scheduled

The City and County of Denver is starting work on a master plan for the government and cultural facilities in the Civic Center area. We're beginning with a planning assessment of the current conditions and issues within the study area, and will include an analysis of how they may be impacted by a new justice center. The planning assessment will focus on issues related land to use, transportation, parking, urban design and parks.

As part of the issue identification, we are scheduling a half-day workshop with various stakeholders on Saturday, August 9th, 8:00 a.m. to 12:00 noon, in the Webb Municipal Building, 201 West Colfax Avenue, Room 4.F.6, Denver, Colorado. All INC members are invited to attend. We are inviting representatives of the government and cultural institutions, representatives of neighborhood and



professional organizations, elected and appointed officials and owners of property within the study area. If you are being invited as a representative of a particular organization and cannot attend, please arrange for another member of the organization to attend in your place. If you are not able to attend, you may watch the event at a later date as Denver's Channel 8 will be taping this workshop for broadcast.

After the planning assessment is complete, we'll present it to the new Mayor and Planning Director for a

decision on whether or not to go forward with a full master plan. If we proceed with the master plan, we'll invite the workshop participants back for a follow-up design meeting focused on solutions to whatever critical issues come out of the first workshop.

Coffee and pastries will be available but lunch will not be provided. Unfortunately we cannot provide free parking. Now it appears that forces who have money are bearing down to repeal QW2 in an attempt to repeal QW2 by using their money and deep pockets to get this on the ballot in an attempt to basically

buy a repeal. I don't think they will be successful in their endeavors but this is a serious threat and it will be up to us to educate people, communities, and the voters at the expense of our personal time, energy and money, as we are all volunteers and INC doesn't have the deep pockets that those opposing us do.

### Tips Offered on Branch Removal, Graffiti

Branch collection continues throughout Denver neighborhoods and Denver Solid Waste Management would like citizens' help in this matter as proper disposal by residents is essential for efficient collection. First, branches must be cut in 4 foot lengths or smaller and be securely tied together in bundles weighing less then 50 pounds. Secondly, loose branches must not be placed in the alley or placed where they interfere with safe traffic flow. For more information, contact Solid Waste Management at 720-865-6900.

Regarding Graffiti, practice the 3 R's of graffiti control. First, report graffiti to the Graffiti Hotline at 720-865-STOP, whether it's on your property, a stop sign, a billboard, a traffic signal post, buildings or anywhere else in the City and County of Denver. Second, remove it quickly by pre-authorizing the city to remove graffiti on your property by completing and returning a signed consent form, or remove it yourself by using free paint that is available to property owners and volunteers from the Graffiti Office. Third, reap the benefits as studies show that graffiti vandalism decreases in areas where prompt removal is practiced. For more information contact the Graffiti Hotline at 720-865-STOP (7867).

Encourage your neighbors to take advantage of recycling with Denver Recycles. There is no charge to qualified residents. Also remind them that recycling is good for Denver's environment and economy. Call 720-865-6805 for more information.


