In attendance were Charles Howard, Bill Johnston, Harriet Hogue, Monique Lovato, Anthony Thomas, Michael Henry, Loretta Galla, Al Habercorn, and Cathee Fisher. The previous minutes were approved. There was no Treasure's report. The Board decided to meet on the 2nd Monday of each month at 6:30pm at 1201 E Williams. The Board discussed upcoming meetings and locations. A couple of INC fundraisers were discussed; Wayne Jochem has volunteered to coordinate the Beer Booths at the People's Fair; and the File for Life is ongoing (this can serve as a fundraiser for individual RNOs, as well). Karen reported that the Neighborhood Handbook is almost ready. Committee Chair volunteers were noted. Cathee reported that she had written a Dollar Dictionary grant application to the Kiwanis Club and will be writing others. Karen reported that the Safety Committee is working on analyzing dark alleys and crime to try to propose alley lighting program. Mike reported that the consultants who are analyzing the Zoning Code have completed their report and will present it to the Zoning Code Taskforce on 3/27 for analysis. He also noted that the next public input meeting is tentatively scheduled for early May. It was suggested that the dates and locations of the next 2 INC Delegates Meetings be in each newsletter. The meeting adjourned at 8:35pm.

## **Minutes of March 12th Delegates Meeting**

Chair Elizabeth Hamilton called the meeting to order at 9:10 a.m. Around The City reports included issues with graffiti, construction, emergency towers, crime, liquor licenses, traffic, zoning, parks and parkways, over-occupancy of houses, homelessness, safety, schools, demolition, bicycle and pedestrian access, and Neighborhood Inspection Services. Announcements were made for the Great American Clean-Up and XCEL Energy's fund-raising training.

Councilman-at-Large Doug Linkhart spoke of issues regarding police assignments and public schools.

Stephanie O'Malley, Manager of the Dept. of Excise and License, spoke on changes in comment-area for liquor license applications and described concerns which are and are not applicable to support or opposition for license approval. She said it is important to appear in person at a license hearing, rather than simply sending your statement in writing in advance.

Assistant City Attorney John Poley also spoke, regarding special conditions for liquor licenses, and transfer of licenses.

INC Committee Reports included a plea for donations to the Dollar Dictionary Drive, an update on Parks Dept. proposed policies for naming and corporate sponsorship (please comment to Manager Kim Bailey), and announcement of the INC Zoning and Planning committee's March 25 meeting.

We're working to ensure that the zoning is enforced for whatever building is proposed.

Buses will shuttle event-goers back and forth along the 'Fax (from Colorado Blvd to Yosemite St) to sample participating restaurants' food. 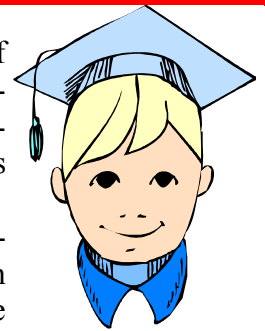

# February Zoning and Planning Meeting Minutes

1. Lee Emsweiler, Duncan Associates, and Noré Winter, Winter and Company, presented a rough draft of their analysis of areas of stability, where demolition is occurring, and the potential historic nature of such property. Lee pointed to the bottom line problem: No one built to the limits of the written code until recently and it has become apparent that the city can't handle the volume that would be created if that "build-to" stays in effect. Lee pointed to an analysis of Carmel, California properties showing that neighborhoods where the houses were in scale relative to each other and had a tree canopy had sale prices ten to fifteen-percent higher than in neighborhoods with lots of scrape-offs. In areas with lots of new out-of-scale homes, only the largest homes could command the same price as the smaller, in-scale homes in other neighborhoods thus pushing the development of larger and larger homes. The conclusion of that analysis, in part, is that "healthy, balanced neighborhoods need to keep scale and tree canopy." Lee also mentioned a Durango survey in which eighty-percent of property owners responding to a survey said that new housing should be of the same scale as existing homes.

The question was asked if there were any strategies (other than a moratorium) to help neighborhoods during the interim until the new code is in effect. Lee answered that they had helped craft interim regulations that contained a sunset clause and that neighborhoods can pursue special avenues such as overlay or historic districts.

Theresa Lucero, CPD Project Manager for the Zoning Code Update, reported that the next steps for this analysis include the consultants meeting with CPD in the next two weeks to present the report and submit the report to the Zoning Code Taskforce for study. Also, a public input meeting is tentatively scheduled for May 10<sup>th</sup>. The full report can be viewed at

And the list goes on but we don't have the space. Nice work Bill!

Monique Lovato—Monique was a former president of the Whittier Neighborhood Association and a

included members from CHUN, Downtown Denver Residents Org, and heavy representation from Golden Triangle.

**Hampden South** – The proposed installation of a 200 ft tall cell tower west of I-25 has been very controversial in our area. Two apartment complexes are going to be redeveloped; one on Hampden east of Tamarac and one on Tamarac across from Tamarac Square.

**Lowry Neighbors** – We are awaiting the opening of our new tavern in One Town Center, while – at the same time – trying to fight the Reading Room (11<sup>th</sup> and Syracuse) outside of our district but impacting our area. The All-Lowry Garage Sale is coming in June.

On a related note, Rick Garcia is hosting a meeting on March 9<sup>th</sup> at 2701 Alcott, 7 to 8: 30 p. m., to discuss scrape-offs in R-2 zones.

2. Tom Kennedy, Director of Neighborhood Inspection Services, thanked INC for its involvement in the NIS Taskforce in 2005. Tom noted that there has been real change in the department as a direct result. His Inspectors gained two hours per day by having Permitting and the developers enforce set-backs and the Inspectors gained additional time when they were taken off telephone-answering duty.

Tom talked about how they were able to sweep the Montbello neighborhood, as they had two extra inspectors for part of 2005. He also reported that Vince Ferrer has been transferred to the zoning desk.

Tom handed out maps showing the new assignments for Inspectors and noted that Inspectors become more experienced and well-rounded if they change territories after a period of time.

There was a suggestion that the Inspectors attend RNO meetings to introduce themselves. Tom encouraged RNOs to contact their new inspector and offered to assist in helping get the RNOs in touch.

There was a suggestion that NIS focus on the educational component as well as the enforcement component so that residents knew the rules. Tom has worked with APNA for several years to put

together an annual “Good Neighbor Guide” that has just that educational component. It’s available at [www.neighborhoodlink.com/denver/athmar](http://www.neighborhoodlink.com/denver/athmar). Hopefully, the Inspectors can leave a copy with each person they contact.

There was a suggestion that RNOs need to let the Board of Adjustment know that the RNOs support enforcement.

There were concerns voiced that 311 will be unsuccessful unless there is seamless sharing of data between the 311 centers and the various City departments.

3. We heard a report on a proposed ordinance regarding review of demolition of structures to give city Landmark Preservation Commission staff time to review potential historic/architectural merit. Several attendees recommended that they coordinate with existing efforts and leverage that work; e.g., Kent Olson’s subcommittee “Report on Residential Zoning and Construction Issues: Recommendations for Improvement”. On a related note, there has been no progress from the City on re-vamping permitting procedures.

#### Other Business

- Chris Nevitt reported that FRESC has finished their third report on TIF.
- Attendees signed a letter supporting the Sidewalk Position Statement.
- Attendees heard of the proposed Emergency Communications Tower (i.e., for police/fire/etc.) ordinance that would allow towers to be 200 feet tall. The ordinance will be heard in the Blueprint Denver Committee on March 8<sup>th</sup>.
- Attendees voted twenty in favor (with three abstentions) to support the Consensus Agreement that has been reached between neighbors, businesses, and the developer of Fillmore Plaza. Those who abstained mentioned that this didn’t seem to be a citywide issue while those in favor pointed to the Agreement’s focus on making a pedestrian-friendly solution that sought to enhance usage - outcomes that could be applied in any neighborhood.
- The Housing Taskforce is ready to recommend their policy for ending homelessness.
- Parks & Recreation is hosting a public meeting at the District Three Police Station to discuss selling the right to name city parks to corporations.

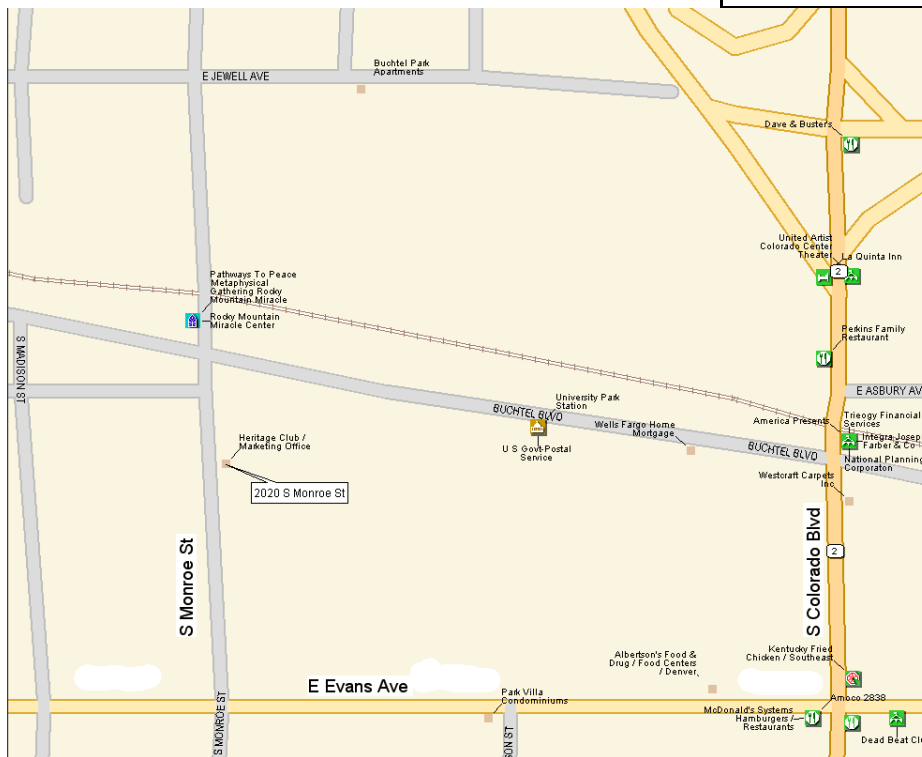

## Fund Raising Training

## Home Improvement Programs Offered in Denver

With still a good month left of cold, snowy weather and rainy spring weather just around the corner, many homeowners find themselves in need of repairing their homes to get through the months ahead. Two programs administered by the Denver Urban Renewal Authority (DURA) could provide **low-interest home improvement loans for eligible homeowners in the City and County of Denver**.

One is the **Single Family Rehabilitation Program**, which provides loans for renovation and rehabilitation of major systems within a residence, such as roofing, heating, electrical, plumbing, insulation, gutters, steps, windows and doors.

- Qualified applicants, who must own and occupy the home, can obtain up to \$30,000 in low-interest loans. Two types of loans are available, with eligibility depending on the individual's income. One is a "pay back" loan at a one percent interest rate, and the other is a deferred loan on which no payments are required, with the loan due only if the homeowner dies, sells the home, or ceases to occupy the property.

A second program, the **Emergency Home Repair**

**Program**, provides deferred loans or grants to correct emergency situations such as a sewer system failure, mechanical or electrical problems that pose a danger to residents, furnaces that are inoperable or are a hazard to occupants, leaking roofs that threaten habitability of the structure and inoperative hot water heaters.

- The Emergency Home Repair Program is for emergencies that would require homeowners to vacate their homes if left unattended, not general maintenance. Eligible homeowners can obtain up to \$6,000 for an emergency repair.

Both programs are designed to assist low-income homeowners. If you think you may qualify, call 303-534-3872. Spanish-speaking staff are available.
