Minutes of January 14 INC Delegates' Meeting

A large group of INC Delegates met January 14 at the District 5 Police Station in Montbello. INC President Elizabeth Hamilton began the meeting with "Around the City." Concerns expressed included graffiti, Main Street and other zoning issues, proposed Voting Centers, need for more library hours, pedestrian safety and sidewalks, the Buchtel Boulevard Coalition, Gates redevelopment (Lionstone and Cherokee), traffic, need for advance notice before demolitions, Fillmore Plaza proposals, liquor licenses, and recycling information.

INC Treasurer Diane Wolta talked about INC's fund-raiser File for Life. INC Zoning Committee reported that City Council is considering a request that the Landmark Commission be notified of applications for demolition, to ascertain whether the building is historic. Some neighborhoods asked that appropriate

Registered Neighborhood Organizations (RNOs) be notified in advance when demolitions are requested, potentially historic or not. Dollar Dictionary Chair Cathee Fisher said that the 2006 brochure is at the printer. INC Membership Chair Ken Beaudrie reminded delegates that memberships are due. Registration with the city also is due. Karen Cuthbertson said that the Neighborhood Handbook is at the printer.

Councilman Michael Hancock welcomed the delegates and said that he "cannot imagine doing the Council job without INC." Mayor's Liaison Tamara Banks mentioned the future 3-1-1 information system, work on environmental issues, and historic dedication in Five Points. Susan Baird of Parks &

Recreation spoke of the Parks and People Partnership and furnished brochures about this program. Matthew Buys of "Your Neighborhood Hub" (weekly in newspapers) suggested that many topics important to INC should be submitted by Delegates for inclusion.

Guest Speaker Michael Bennet, Superintendent of Denver Public Schools, spoke about the District's Reform Agenda: raising proficiency, setting high expectations everywhere, tutoring, emphasis on achievement, teacher retention, and professional development of teachers and principals. School Board President Theresa Pena talked of aligning resources, curriculum, and the lives of adults and children. A

Citizens Asked to Nominate Exceptional Police Officers

Citizens Appreciate Police (CAP) is a non-profit organization that recognizes Denver police officers who serve the public above and beyond the regular call of duty. Since it was formed in 1978 by Mayor Bill McNichols and District Attorney Dale Tooley, more than 200 officers have received the CAP award.

The CAP board, consisting of 15 citizen volunteers, meets four times a year to review nominations, select recipients, and present awards. Each award winner receives a pin that is worn on the officer's uniform and a plaque. Nominations for the CAP Award come primarily from letters to the Chief of Police from private citizens commending an officer for their actions while either on or off duty.

Around the City

From January 14, 2006

INC Meeting

Baker – Gates is proceeding in the redevelopment and will put some financial plans together in the next month. The Fentress development at 4th and Acoma is trying to go forward, but keeps making “small changes” after an agreement was reached last year.

Capitol Hill United Neighborhoods – Has been working for three years with business owners and the city to develop a new type of zoning – Main Street. City Council probably will apply this to the stretch of East Colfax between Grant and Colorado Boulevard in the next few months.

Cherry Creek North – Councilwoman Jeanne Robb held a public meeting attended by 350 residents and business owners to fashion a new vision for Fillmore Plaza. Several potential plans were presented and discussed. This public input will be addressed by a working group and the results presented at another public meeting in the near future. Neighborhood residents overwhelmingly want to keep the plaza (rather than convert this area to a through street).

Cook Park – Interest in INC challenging Denver Public Library hours, perhaps keeping afternoon/evening hours for families and students. Virginia Village Library closes at 5 p.m. except Wednesdays,

8 p.m.

Cory-Merrill – Traffic speed issues continue. Construction activities and volume affect neighborhoods by invading parking, increasing trash.

Curtis Park – Focus is on solving the current zoning and its effect on maintaining the residential and historic character of the neighborhood.

Godsman – Officers were re-elected. Scott Bolts may run for City Council District 7. Godsman neighborhood supports him.

Golden Triangle Organization – The organization is continuing input on Justice Center and Art Museum addition, and is working with CHUN to oppose two liquor license applications (one on Broadway, one on Lincoln) at sites offering virtually no food. Enough already!

Hampden South – Owners of an apartment complex on Hampden (West of Yosemite) want to redevelop to higher density and will present plans to the Zoning Committee. Construction continues on the I-25 bridge, businesses, apartments and the Walgreens parking lot. Permit review is in progress on Whole Foods’ request for an access gate from its south parking lot to a neighboring subdivision. Legal procedure was requested on an untended vacant property. A study is underway for a final location decision for a Police Communication Tower near I-25 and East Hampden.

Harkness Heights – The Victorian Playhouse opened in the fall of 2005.



University Park – Four major development projects will add hundreds of new residents (and their vehicles) and a number of new businesses to UP. Also, dozens of scrape-off/pop-top sites are changing the look of residential blocks (1957 zoning allows extensive density on sites which have long held small single-family houses.) The neighborhood’s focus is also on city regulations for sidewalks, and

construction and landscaping in “tree lawn” right-of-way areas.

West University (WUCA) – The Buchtel Boulevard Coalition consists of nine registered neighborhood organizations, Lionstone, DU, and other groups. It is underway with bylaws, officers, and committees appointed for rapid progress on its mission statement – to see Buchtel fully developed as a primarily residential boulevard.

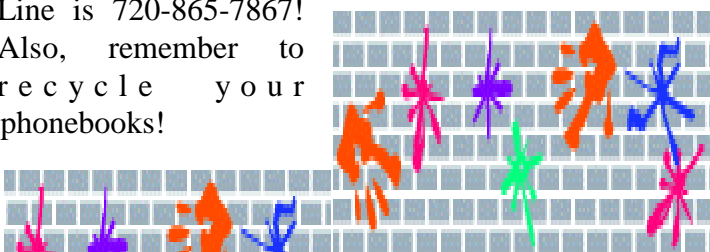
West Washington Park – A “surprise Christmas present” came in the form of a surprise demolition of an International style building at Speer and Washington, which neighbors wanted to have evaluated for historical significance. City Council’s Blueprint Denver Committee is encouraged to pursue ordinance revision of demolition regulations that will provide opportunity to evaluate potential historic value of a building before it is demolished.

Whittier – Its primary concern at this time is the large amount of graffiti to clean up.

Denver Parks and Recreation – Is looking for volunteer Park Partners to give a monthly “report card” on the condition and maintenance of their neighborhood parks. A one-hour training session is provided. To get your parks covered, call 720-913-0617.

Denver Parks Develops Policy On Gifts, Naming & Sponsorships

Denver Parks and Recreation will briefly present information on four departmental policies relating to gifts, naming and sponsorships on Saturday, February 11, 2006 at the monthly INC meeting. Each policy outlines the criteria and procedures for the city to accept gifts or sponsorships, consider naming, and recognize that donor or sponsor. The Department's goals for these policies are two-fold. First, they will help the city respond consistently and thoughtfully to the requests received from potential donors and sponsors. Secondly, it helps the Department to be more proactive in seeking partnerships that further the Department's priorities and the long range vision for parks and recreation.

These policies are critical in building partnerships. Over a decade ago, the Parks and Recreation Advisory Board created internal policies covering gifts and community requests to name parks. These existing policies, however, had not caught up to today's realities nor did any policies even exist on



sponsorships or naming requests from a major gift donor. A Task Force of community and staff members started working late in fall of 2004 to update and create policies to meet the needs of today's situations. Its work was revised and approved by the Parks and Recreation Advisory Board November 2005.

For over 100 years, Denver residents and businesses have given generously to their parks and recreation programs. These gifts and partnerships run the gamut, from individuals to major corporations and have often turned the mundane into something spectacular. A variety of examples exist from William McLellan, the blacksmith who donated one of the elaborate City Park stone gates to Oakwood Homes, a developer that sponsors summer programs in parks in the Green Valley Ranch neighborhood.

The need for revenues beyond the traditional tax dollars and for new partners has never been greater. Denver's parks and facilities have aged over their lifetime and face a yearly gap of over \$4 million just to maintain what exists. Denver, like cities across the country, is challenged to be more entrepreneurial while staying true to its public mission and stewardship of public spaces. The departmental policies presented are aimed at providing a proactive and positive framework by which to guide future decisions.

In addition to presenting these policies at INC, a public meeting is scheduled for March 9th, 2006 at the District #3, Denver Police Station, 1625 South University Boulevard. For additional information, please contact Susan Baird at 720-913-0617.

Items on the agenda will include an update on the Pilot Travel Shed analyses, a summary of the recent focus group meetings, and a discussion of the next areas to be studied.

Buchtel Boulevard Coalition Formed

INC members quickly learn that when neighborhoods have serious concerns, the more widespread the support, the more seriously the concern is taken.

A number of neighborhoods along the southeast T-REX light rail line, from South Colorado Boulevard to South Broadway, have adopted this method. They have formed a coalition of neighborhoods, businesses, schools, and other groups to work to provide a safe, continuous pedestrian and bike route along three miles of primarily residential Buchtel Boulevard.

Many familiar INC faces were at the first major meeting of the Buchtel Boulevard Coalition (BBC) January 18, as well as some new faces, and with the important presence of Public Works T-REX Area Manager Bob Dorroh, Britta Herwig of Parks and Recreation, RTD Board's Bill Elfenbein, RTD Bike Chair David Kretsinger, Aylene Quayle of Transportation Solutions, and Jeff Bemelen of the University of Denver.

BBC is not an INC subcommittee, but it shows that in the grand INC tradition neighborhoods with a complex local project can unite for considerable support and numbers to help accomplish their common goal. Seven RNOs are members of the BBC, which is chaired by Charles Howard (WUCA) and Mary Myers (UPCC).

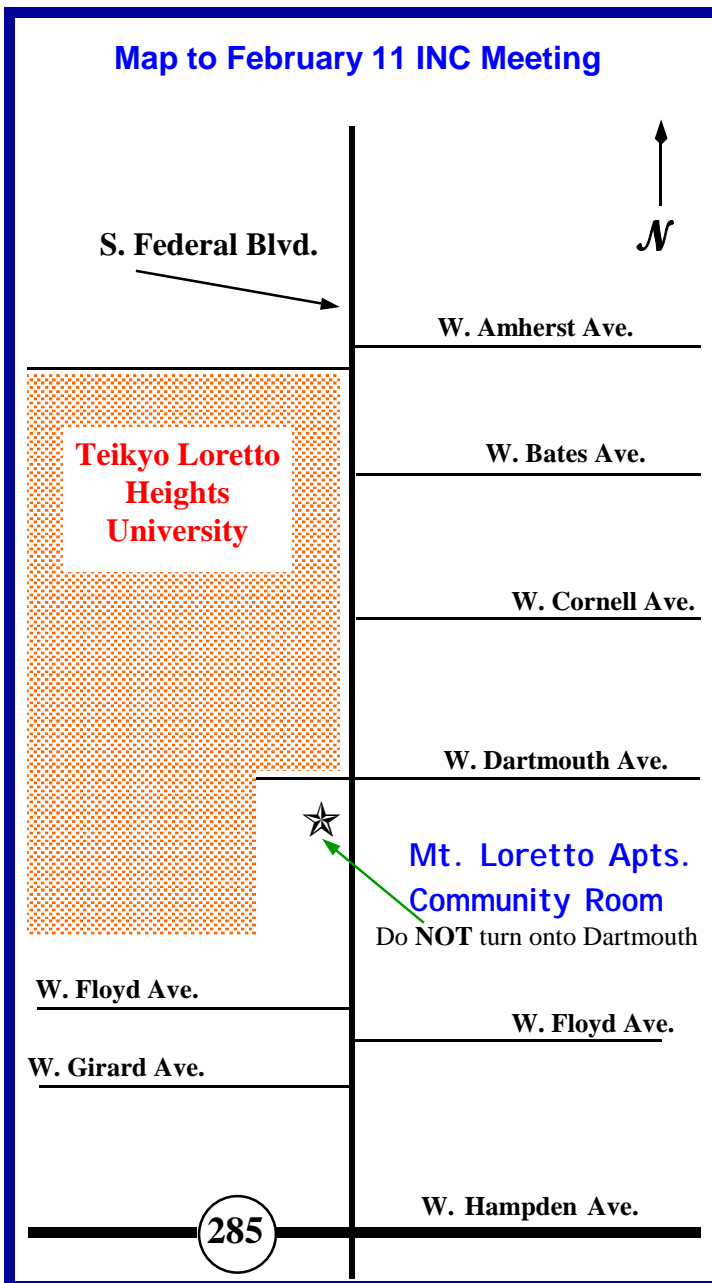

Recycling Tips: Household Hazardous Waste Disposal, Composting Classes

When disposed of improperly, even small amounts of household hazardous wastes can pollute ground and surface waters, thereby causing harm to humans and the environment. Examples of household hazardous waste include common household cleaners, oil-based paints, motor oil, solvents, pesticides, auto batteries, thermometers and pool chemicals. These items should not be put in the trash or poured down drains. Instead, Denver residents can call for an appointment to have their household hazardous waste picked up.



The City of Denver, through a contract with Curbside, Inc., provides for the collection of household hazardous waste. To make an appointment, a resident must be a Denver Solid Waste Management customer and reside in a single-family home, town home or apartment building of seven units or fewer. Eligible residents then call the Curbside, Inc. toll-free hotline at 1-800-HHW-PKUP (1-800-449-7587). Residents are permitted one collection per year not to exceed 125 pounds and must have a minimum of three different materials before calling for a pickup.

A few days before the scheduled appointment, the resident will receive a collection kit in the mail. The kit includes a bag to contain the waste materials, instructions, labels and a tie to secure the bag. The user should assemble all of the hazardous waste according to the instructions provided in the kit. The labels that are provided should be used to ensure that

Minutes of January 28 INC Zoning and Planning Meeting

The INC Zoning and Planning (ZAP) committee met January 28, 2006. AIMCO, a real estate investment trust, presented proposed redevelopment ideas for Tamarac Village, The Lodge, and Creekside, to upgrade and increase the densities of these areas while trying to coordinate style, traffic, height and other features with the surrounding neighborhoods. Similar redevelopment may be occurring in other areas. ZAP members commented that perhaps Planned Unit Developments (PUDs) could be considered rather than rezoning, and that it is essential that Registered Neighborhood Organizations (RNOs) be notified and consulted regarding such projects.

Chris Nevitt of Front Range Economic Strategy Center (FRESC) talked about tax increment financing (TIF) and part three of the FRESC study "Are We Getting Our Money's Worth?" an alternative view will be presented at a future ZAP meeting.

The committee voted to send this motion to the INC delegation for action: "INC should request the Denver Urban Renewal Authority to involve nearby registered neighborhood organizations during the preparation of proposed urban renewal plans and to give adequate advance notification of any hearings on urban renewal plans before the DURA board or City Council."

A proposal to require notification and ample time for review of properties for which a request for demolition has been filed was presented. This proposal, dealing with the need of the Landmark Commission to check such properties for their possible historic value, was supported by ZAP members on condition that the proposal include the request contained in the ZAP subcommittee's 2005 zoning improvement document asking for 30-day

prior notification to properties next door to the requested demolition and posting of an appropriate informative sign on the property (that document has been endorsed by INC delegates). ZAP will write a letter to City Council regarding support of this inclusive proposal.

There was a brief report on a formal meeting of several ZAP subcommittee members with Peter Park and other Community Planning and Development staff members on January 24. The eleven zoning improvement suggestions in the subcommittee's document received serious consideration, and further discussion will be scheduled.

There is a need for timely, 30-day notification of rezoning and PUD hearings at Planning Board. A letter requesting this will be sent by ZAP to the Planning Board and Peter Park.

Four vacancies are coming up on the Planning Board in June, 2006. ZAP members are asked to recommend candidates to Chantal Unfug in the Mayor's office.

Mary Myers presented the position paper developed by the Sidewalk Committee of the University Park Community Council. It urges that the Pedestrian Master Plan be funded and implemented, and that sidewalk construction be funded by means other than billing homeowners.

ZAP members voted to present this document to the INC delegates for approval on February 11.

Councilwoman Jeanne Robb discussed child care facilities. Wayne New, President of Cherry Creek North, discussed Fillmore Plaza proposals. At the next ZAP meeting, February 25, Nore Winter, a consultant for the Zoning Code rewriting project, will speak on "Tools to Stabilize Stable Neighborhoods."

materials are clearly marked. Containers must have lids and be of less than gallon capacity. Materials without lids or those that are leaking will not be accepted. The bag holds approximately 125 pounds. Up to five auto batteries and five fluorescent tubes may be set outside the bag once it is full. If there is more waste than will fit into the bag, the resident should call the hotline for instructions.

The household hazardous waste collection program is supported through a cooperative effort between the Wastewater and Solid Waste Management divisions of Denver Public Works.

Composting Classes

Denver residents have an opportunity to register to be Master Compost Volunteers and receive 40 hours of instruction in backyard composting, recycling and waste reduction, compost science, compost bin construction, vermicomposting (composting with worms) and integrated solid waste management and community outreach.

In exchange for the training, each volunteer is required to return 40 hours of community service teaching composting to Denver residents. Volunteers will have a year to complete their community-service requirement. There is no charge for the instruction, but a classroom fee of \$40 is required.

Classes start the first week of March and will be held about once a week for 10 weeks on a combination of Monday evenings, Saturday mornings and one Thursday field trip.

Only 25 available spaces are available each year, so interested applicants should call 303-292-9900 or e-mail denverrecycles@ci.denver.co.us as soon as possible.

The Master Composter Program is sponsored by Denver Recycles, a program of Solid Waste Management, Denver Urban Gardens, and the Metro Wastewater Reclamation District.
