The annual registration of all neighborhood groups who wish to receive notices from the city of proposed zonings, zoning variances, new liquor license applications and many other actions that neighborhoods affect must be submitted by January 31, 2006.

Each currently registered neighborhood organization (RNO) should have received notification in December, with instructions for how to reregister. New groups are welcome to register also, as long as they meet the criteria in the registration and notification ordinance, which was first passed by City Council in 1979. The registrations are sent by the city's Community Planning and Development Department to the current contact person for each group. If a group's contact person has been replaced, it is very important for the group to be sure that it gets and submits the registration form.

Minutes of Dec. 10 INC Delegates' Meeting

INC Delegates and friends met December 10, 2005 at the District 3 Police Station in southeast Denver. Many thanks to Virginia Vale/Ellis, Leetsdale Cop Shop, Washington Park and Councilman Charlie Brown for helping host.

Speakers not the on agenda included Councilpersons Brown and Carol Boigon, and City Auditor Dennis Gallagher. Councilman Brown advised that there are 113 miles of flagstone sidewalks in Denver. Councilwoman distributed information about Child Care Centers (an amendment may be proposed to state that these do not have to be connected with churches). Auditor Gallagher stated that "the trust of the people" is the most important quality of good government, and distributed a telephone number we may call to reach him with comments:

"Around the City" reports dealt with graffiti, newsletters, drugs, inclusiveness, construction, parking, zoning, sidewalks, tax increment financing, liquor licenses, water projects and rates, wastewater and recycling, and engaging the Denver Municipal Band for neighborhood events (see "Around the City" on page 4).

Susan Baird spoke on matters related to Parks and Recreation (winter activities such as sleigh rides, snow-sculpting, the new alcohol-in-parks policy, scholarships to recreation centers, and a new policy for corporate sponsorship and the naming of parks - which will be on the INC agenda in January 2006). Monica Martinez of the Mayor's office reminded us to register RNOs by January 31, 2006, and that we may address neighborhood concerns to her or Tamara Banks.

Paul Kreischer of Lightly Treading Energy and Design (303-733-3078) presented a program on energy audits and ratings and construction management, which is this company's business. Many houses can be made more energy efficient.

There was not time for the other two agenda items listed (Emergency Preparedness and INC Sidewalk Position statement). The sidewalk concern will be addressed at the January or February INC meeting.

Neighborhood groups which fail to register risk failing to receive important notices. Every year a number of active RNOs, for a variety of reasons, fail to re-register. Being on the official registration list is the life-line for neighborhood groups.


One new standard required for groups to register was added by City Council in January 2005. Groups that wish to register now must certify that they had an annual meeting in 2005 at which at least 12 persons were in attendance. All groups should keep this in mind in planning their annual meetings.

Registration can be done on-line through www. denvergov.org by clicking "Neighborhoods" and then "Neighborhood Organizations."

The official city registration for RNOs is not the same as joining or re-joining Inter-Neighborhood Cooperation (INC), which is an unofficial association of neighborhood groups. Members of INC are reminded, however, that 2006 dues are payable at this time if a neighborhood wishes to remain a member in good standing. Also, the membership application found on page 9 of this issue may be used for updating delegate information for INC records.

From the December 10, 2005 INC Delegates' Meeting

Athmar Park – APNA and Denver Partners Against Graffiti are working together to try something new in the fight against graffiti. APNA has committed to have residents go door-to-door to get residents and businesses in a small region to sign the release form necessary to allow DPAG abatement teams to wash or paint out graffiti. DPD officers and DPS officials will work also to help identify offenders and enforce penalties, including holding property owners accountable for cleaning their property or calling the city to do it. More to come.

Baker – The neighborhood is concerned about traffic patterns at Broadway and I-25. Current onramp closure puts more traffic on Broadway, and Gates redevelopment will change the traffic flow.

CHUN – The annual CHUN Grants ceremony and presentation of awards was December 12 at the Botanic Gardens, with Mayor Hickenlooper as speaker and all in the community invited.

Cory-Merrill – Traffic safety/speeding on Mississippi, Arizona, Louisiana, Arkansas, Florida and Steele, are the primary focus of concern of residents. Lack of patrol in critical time periods (rush hours, school pedestrian activity) creates dangerous safety situations.

Five Points Historic Assn. – The association's third annual holiday party was scheduled for

December 20 at Blair-Caldwell African-American Research Library. Watch for the Heritage Lecture Series kick-off in February. The Mestizo-Curtis Park Alliance seeks advocates for park and community programs. For additional information, contact Cathy Bellem at 720-635-6731. Watch for the Quick Park Dedication in June 2006. Historic Denver is providing a seminar entitled "Stories on Your House" to teach techniques to research and record your home's history. Contact FPHA or Historic Denver. org.

Golden Triangle – The association had a wonderful Christmas Party December 8 at the newly opened Boulevard Apartments. It is a balanced organization of business developers and residents. This year the board has a majority of residents.

Godsman – 1100 S. Raritan — police are still making drug arrests, although there are fewer. The neighborhood continues to appreciate District 4 police for their work in the area, and traffic control for their work on Florida Avenue. NIS is doing a great job helping to get the neighborhood in line with city ordinances.

Hampden South – The new Whole Foods grocery is open in the old Tiffany Plaza Center. Walgreen's construction there is nearing completion. A transit related apartment building is under construction at I-25 & Hampden. A police communications tower is anticipated to be built at Hampden and I-25 - - more details to come. 4011 S. Quebec is still empty and problematic. The association is pleased with help from Councilwoman Lehmann and her staff.



University Park – Several hundred attended the annual UPCC Holiday Sing and wagon-rides in Observatory Park. The developer's request for RMU-30 zoning (from the present PUD which UPCC had designed with Albertsons some years ago) for the northwest

corner of East Evans and South Colorado Boulevard was approved by the Planning Board December 7

with several conditions requested by the UPCC Board.

Auditor's Office – Mr. Gallagher is working with City Council and the Mayor on the scope of the police audit, to begin early in 2006. The office is collecting toys for Denver Human Services – Kids make a difference! Telephone Tip Line is 720-913-5063 or e-mail Auditor.info@ci.denver.co.us.

FRESC – (Front Range Economic Strategy Center) Its work on the Gates/Cherokee Voluntary Cleanup Advisory Board (VCAB) continues, together with volunteers from West Washington Park, Athmar Park, Baker, Platt Park, and Overland. A community forum with the state health department was well attended, and gave information about tricholcethylene contamination and plans to test for and remediate possible threats to houses. FRESC has published Part II of its study on the public development subsidy of tax-increment financing (TIF), "Are We Getting Our Money's Worth?" It looks at the quality of jobs and affordability of housing being created by taxfunded subsidies. It finds that Denver TIF subsidies are, unfortunately, creating low-wage/low-benefit jobs and high-end housing-- not a sustainable development strategy.

INC - A new Newsletter Editor is needed. Craig

Larry Brown with the Lowry Community Church is handling a lot of follow-ups. Several fund-raisers in the Town Center support community grants with the Lowry Foundation. On to 2006!

Message from Neighborhood Liaison

Happy New Year from the Mayor's Office! The holiday season has been busy, with much news to report. Some of the December highlights are included below. We look forward to working with INC and all of Denver's neighborhoods in 2006!

Justice Center

On December 15, Mayor Hickenlooper announced that the City and County of Denver will begin

immediate contract negotiations with Steven Architects Holl Hartman-Cox Architects to design the Denver Justice Center courthouse a n d detention facility, respectively. Both firms were chosen by the 15member selection jury following a competitive



RFQ/RFP process that included interviews with the selection jury and public presentations.

Holl was named *TIME* magazine's 2001 Architect of the Year and received the Smithsonian Institution's 2002 Cooper Hewitt National Design Award in Architecture. The New York-based SHA design team includes Denver-based Klipp Architecture Planning Interiors and New York-based Ricci Greene Associates. Hartman-Cox Architects have also won numerous national awards, including the American Institute of Architects Firm Award, the highest honor the AIA bestows on a firm for design. The Washington, DC-based HCA design team includes Denver-based OZ Architecture, Boulder-based

Voorhis Robertson Justice Services, and Ricci Greene Associates.

Nearly 2,000 people turned out for the finalists' public presentations in early December. Many of the architects expressed awe at the level of community interest and participation, citing it as one of the reasons they were so eager to work in the Mile High City. Thanks to all of you who attended.

Public Safety

In early December, Mayor Hickenlooper unveiled new initiatives related to the city's longstanding, multi-pronged approach to improving public safety. This plan includes the retention of internationally recognized police management and crime reduction consultants, the Hanover Justice Group, to create an action plan for enhanced crime reduction and police effectiveness, a concurrent systems analysis of patrol and investigative operations by the U.S. Air Force Academy, and the creation of a staff position to help the Denver Police Department implement these strategies and enhance data collection and analysis. These strategic efforts will leverage the city's \$17.4 million investment in training 465 new police recruits between 2003 and 2006 and \$22 million investment in new safety-related technology enhancements.

The Hanover Justice Group team, led by crime control strategist Dr. George Kelling, has been contracted to create an action assessment identifying the strategies and organizational support needed to reduce crime, increase public perception of safety, and ensure that police have the staffing levels and tools they need. Kelling is one of the country's best known crime control and police strategy theorists and co-author of the "broken windows" theory of crime control — one of the strategies credited with New

York City's crime reduction success. The Denver Police Foundation is paying for the Hanover Justice Group's six-month contract, so no tax dollars will be used.

Mayor's Design Awards

On December 2 the city hosted Denver's first-ever Mayor's Design Awards ceremony at the Colorado Convention Center, honoring design excellence in 15 smaller-scale projects that contribute to the vibrancy and character of Denver neighborhoods. The mix of projects included retail stores, restaurants, an urban market, a museum, an apartment building, an event and even a magazine. Green Cities Forum

In late November, Mayor Hickenlooper hosted a public Green Cities Forum at the new Ellie Caulkins Opera House, featuring sustainability experts from Oakland, Chicago, Seattle and Salt Lake City - cities well known for their successful work in the field of sustainable development. The forum was well attended by both sustainability-related professionals and interested citizens. The Mayor's Sustainable Development Initiative was launched in April 2005 to promote programs and policies that support the environmental, economic and social benefits of sustainability. INC Distributes Lifesaving Material

Inter-Neighborhood Cooperation is sponsoring a program which will save lives while it raises funds. The program is "File of Life," part of a nationwide effort to save precious time when medical personnel respond to an emergency.

Recognizing that, in many situations, a patient who

is in need of medical assistance cannot communicate with emergency medical technicians and others, "File of Life" makes essential information immediately available to those



who need it. It consists of an information packet designed to fit into a wallet. After the data is entered by its owner, the packet contains the owner's name, emergency numbers, health insurance policy information, a list of medications and dosages, allergies, a health care proxy, and other information designed to facilitate immediate treatment and lessen the possibility of medical errors.

The "File of Life" is being offered by INC for \$1.00 each. They are available at INC meetings. Delegates will want to have one for each family member, and neighborhood associations may want to purchase a

quantity of the packets to distribute throughout their neighborhoods or to use as a fundraiser themselves. "The card eliminates the risk of a patient, in a frightened state, forgetting to mention something important," according to M.G. Ishler, Director of the South Hadley, Massachusetts, Council on Aging.

Thus far, the "File of Life" is being used by over 1600 communities and can be found in 2,500,000 homes.

Recycle Christmas Trees, Phone Books

For the two week period from January 3rd through January 13th, Solid Waste Management/Denver Recycles will be collecting and recycling old Christmas trees from residential homes that are Denver Solid Waste Management customers.

How to recycling a Christmas tree:

- Remove all tinsel and decorations from your tree.
- No artificial or flocked trees, tree stands or trees in plastic bags.
- Set your tree out on your trash collection day near your normal set out location during the two week period starting January 3. Residents with dumpster collection service should place their trees out for collection on Tuesday, January 3 or Monday, January 9.


Be sure your tree is set out by 7 a.m. and has at least

4 feet clearance from any containers, bags, dumpsters or other obstacles.

Call For Award Nominations

For several years, Inter-Neighborhood Cooperation has given three annual awards to express INC's appreciation to individuals who have helped Denver neighborhoods.

They are named after three of INC's finest leaders, all now deceased.

The first is the **Virginia Oredson Award**. Virginia was the secretary of INC for several years in the 1980s and was very active with the Montclair Civic Association. She was a gentle lady with firm ideas about protecting her neighborhood from crime and problem bars and encouraging neighborhoods to work together through INC.

The Virginia Oredson Award is given to a person who:

- · Has encouraged Denver neighborhoods or citizens to work together in a common effort to solve community problems;
- · Has established a record of selfless community service encouraged and motivated others to volunteer their services to engage in community improvement efforts.

The second INC award is the **Bill Gross Award**. Bill was the chair of INC in the early 1990s and had been very active as president of the Whittier Neighborhood Association and was an organizer of the Northeast Denver Congress. His particular passion was building partnerships between neighborhood groups and the Denver police to improve neighborhood safety.

The Bill Gross Award is given to a person who:

- · Has a strong record of working with neighborhoods to better public safety in the community;
- · Has made Denver a safer place in which to live.

The third INC award is the **Walt Kembel Award**. Walt was the treasurer of INC in the late 1990s and was active in the Cherry Creek North neighborhood, where he constantly and vocally, although unsuccessfully, tried to maintain the neighborhood character of smaller, modest homes in the North Cherry Creek area.

The Walt Kembel Award is given to a person or group who:

- · Is an INC delegate or a member of a Denver RNO;
- · Has contributed to INC during the past year over and above normal expectations to develop and promote the organization or has moved INC forward or in new directions in creative or unexpected ways.
