NC Transportation Committee

Happy New Year! The Inter-Neighborhood Cooperation Transportation Committee will be continuing its schedule in 2014, meeting every other month on the second Thursday of the month, 6:00 p.m. at 1201 Williams Street, 19th Floor. Our next meeting is on Thursday, January 9th.

We hope your neighborhood can send a representative to the committee as we discuss a range of transportation, transit, and streets topics, build connections with the agencies and organizations involved, and ensure that neighborhood input is included in plans at all levels!

Attendees do not need to be neighborhood INC delegates -- all are welcome. Even if your neighborhood organization is not a member of INC, you are welcome to participate. Please pass this on to anyone who might be interested in joining the committee. I would be happy to add them to our growing e-mail list.

Thursday January 9th, 6 p.m.

We have three topics for our meeting:

Redesign of Civic Center Station -- Kate Iverson, Manager of Transit-Oriented Development at RTD, will be presenting early design concepts for Civic Center Station at Broadway/ Lincoln and Colfax Avenue. The current station structure is nearing the end of its useful life, and is experiencing problems from water infiltration to the wearing out of the springs which isolate the indoor bus ramp floor from the parking structure below. The new design will use State of Good Repair funds to both rehabilitate the station and create more efficient bus circulation that supports the new Free MetroRide circulator, the Free MallRide on 16th Street, and the many buses that serve the station. This early design concept also creates the opportunity for additional development along Colfax between Broadway and Lincoln that will be one subject of a station master planning effort to kick-off in

Brighton Boulevard Corridor -- Karen Good, Project Manager II in Denver's Public Works department, will present an update on the design for the Brighton Boulevard Corridor. Examining the Brighton corridor from 29th Street to the City limits north of I-70, the study sets the vision for public multi-modal right-of-way improvements, helping establish it as a gateway to Denver. This project recently completed public workshops and technical analysis to develop recommended cross-sections in four unique character areas, designed to accommodate all modes of

travel, dedicate spaces for tree lawns, and allow for a phased approach to implementation that minimizes cost and maximizes opportunities for implementation to occur on a property-by-property or block-by-block basis as opportunities allow. The phased implementation where initial investments are built upon in future phases is a very interesting part of this project. The project is part of the North Denver Cornerstone Collaborative.

Denver Union Station/Cherry Creek/Glendale Corridor Feasibility Study -- Rich McClintock, Executive Director of Transportation Solutions will present on a recent study to identify transit demand between Denver Union Station, Cherry Creek and Glendale, identify service options and service levels that best meet the corridor needs, and recommend service options that connect these activity centers efficiently and effectively. The study is an excellent example of private and public entities working together to study and influence transit service design in the context of existing and expected travel demand in areas with increasing density.

Executive Committee Meeting Minutes

In attendance: Jane Lorimer, Steve Nissen, Katie Fisher, Blake DeMeo, Randle Loeb, Larry Ambrose, Karen Taylor, and Michael Henry

November Minutes were approved by Randle and Seconded by Jane Lorimer and accepted by acclamation.

Steve Nissen brought up whether INC should donate to other RNO organizations. Jane said there have been five requests from neighborhood associations. The discussion centered around whether INC is a funding organization. Larry believes that a policy is needed in this regard and will work on a draft for consideration by the Board. Katie Fisher made a motion not to donate to any neighborhood organizations this year and motion carried.

A motion was made by Jane Lorimer that INC purchase a \$100.00 table at the annual dinner for the Denver Office of Strategic Partnerships. The motion was seconded by Blake and approved by all.

Jane reported the membership renewals will all be mailed by December 15. Non-member RNO solicitations will be mailed by the end of 2013 or sooner. Each renewal/solicitation will include a personalized letter and appropriate application form. Our new "rack card" will be provided with all solicitations.

Jane announced her retirement from her now four-year role as interim membership chair to be effective at end of current Board term, which occurs when the new Board is elected in March 2014. She will train the person appointed to head up membership. An "ad" ran in the December newsletter and will be repeated in next couple of newsletters.

There was discussion about what the wording on the award plaques as the awards were redefined this year for clarification of recipient deeds. Should the name of the honoree and recipient both appear on the awards? Katie made a motion that they should appear on this transition year and Randle seconded. The motion approved by acclamation. The award winners will be voted on during the next board meeting on January 6th.

Parks committee requested \$300.00 in next years' budget.

Zoning Committee recap. INC has sent a letter to Rocky Piro regarding open space in General Development Plans. The Hancock Administration has promulgated text amendments, which include codifying a reduced amount of open space in all new large developments. INC will continue to fight against this ill-advised public policy.

Education Committee – Karen will ask Benita to email Larry re: time on January's agenda for DPS updates and new board member introductions.

A suggestion of hosting Dr. Bruce Mendelson a substance abuse expert as an INC program feature was made by Randle. He will be considered, as well as remembered as a possible speaker for the neighborhood conference.

Randle reminded everyone of the service on Dec. 18th to remember the homeless who have passed away this year.

The meeting was adjourned at 8:50

From The President

Denver's Neighborhood Voice in the Wilderness

Cynicism runs deep in American politics these days. It wouldn't be so bad that politicians mislead, misjudge, misconstrue and misstep, but, the problem is, they run our government! Although, most of



our elected City government representatives, have come to office through the highest calling of civic service, many seem to fall prey to a dominant political culture, whereby citizens

are patronized rather than respected. Somehow we are often made to feel like the teenager asking to borrow the car on Saturday night, rather than the taxpayers who put them in office.

Assuming that term limits were supposed to reduce the probability that bad elected representatives would continue on in office, they have had the opposite effect. In many cases, they have assured that mediocre representation will be perpetuated through a guarantee of 12 years of incumbent election funding. Investigative journalism at the local, state and national level which informs most voters, has gone the way of the trolly cars. At the local level where citizens have the best chance of effecting outcomes and change in gov-

ernment, so much money is needed for Council and Mayor races that lobbyists and, developers have joined forces to run their own candidates who answer first to them.

Denver government presents a perfect example of where the public processes for citizen involvement have become a sham. Agency bureaucrats, often consider themselves to be experts and know best what citizens want and need. Most of the time planning is done with predetermined outcomes. Committees in which the public is allowed to participate, shadow "internal" work groups where policies are developed and are then presented for consideration as limited options. Requests for "costbenefit" analyses go unheeded. Final plans are submitted to the public only for 'tweaking". Stakeholder committees, have now become confidential in nature with citizen participants being asked to pledge to keep proceedings and the discussions to themselves and from members of the press and public. Even a former Councilperson, was recently ordered to leave a stakeholder Special Events and Planning meeting as " it was deemed a "private" not "public" meeting and she was not on the "invitation" list.

When there is a valid public process, the published outcomes are often subverted, altered by the agency experts or even totally ignored at a later date. Outcomes, written vaguely or with the addition of ambiguous terms, makes possible almost any interpretation that is needed to support


questionable government decisions.

City Council committees hear from City agency experts and lobbyists and make decisions without the benefit of public comment. "Courtesy Zoning", whereby City Council follows an unspoken rule that approves site specific zoning matters according to the District Councilperson's wishes, has morphed into "Courtesy Parks" and actually, "Courtesy Anything".

City Attorneys mold interpretations of the law to satisfy the Mayor's whims. City Council, the legislative branch of municipal government has no legal counsel of its own and has blindly followed the legal opinions of the Mayor's appointee. Only since the Mayor and Council became "term limited" has the legislative branch of City government so eagerly followed the Mayor's wishes. Historically, Councils have often hired their own outside legal counsel. Denver now, at least in theory, has only two branches of government--Executive and Judicial. The legislative branch has abandoned its oversight role as the legitimate third branch of our government. One big, happy family rules the city.

Trees are falling in the forest. We hear them fall. Be it resolved that we must work to stop this madness in 2014.





The purpose of INC shall be to:

- F.) Take an active role in working with city government and others in shaping Denver's future.

INC is seeking members to run for its Board of Directors for the 2014-15 term (one year). To be eligible, you must be a delegate from your member RNO. The election will take place at the Delegation meeting on March 8th. Make sure your RNO renews its INC membership so that you can vote at the March meeting. Terms are for one year with a two-year term limit: March 2014-March 2015. All nine positions on the Board of Directors are up for election. Those offices are: President, Vice President, Secretary, Treasurer, and five Delegates-at-Large.

INC's mission is to advocate for Denver citizens by bringing together, informing and empowering Denver neighborhood organizations to actively engage in addressing City issues. By serving on INC's Board you will also:

- Deepen your understanding of the community, its residents and their needs

Candidate Process:

Only Delegates from INC Member Organizations, whose dues are paid by the time of the election (March 8), are eligible to fill Board of Directors positions. All candidates must be formally nominated at the time of the election; therefore, candidates are encouraged to provide their names and desired positions to the INC President as well as be prepared to have someone nominate you from the floor at the time of the elections. This will allow us to prepare a ballot in advance. Additional nominations can be added.

Neighboring Ash Borer Cleaning Help For **Infestation Shows Importance of Denver Digs Trees Program**

Deadline for Tree Applications: Feb. 15

Over the past 29 years, the Denver Digs Trees program has provided more than 46,000 affordable and free trees to Denver residents, helping to enhance quality of life in our city. Trees beautify our neighborhoods, enhance property values, lower utility costs, improve air and water quality, and much

This spring we are combining our annual spring street tree distribution with our fall yard shade tree program, offering Denver residents the opportunity to purchase low cost trees for their yard and/or in the public right-of-way.

Trees will be \$10 in our 25 target neighborhoods* (neighborhoods with the least tree canopy coverage) and \$35 throughout the rest of the city. The trees that we sell routinely sell for \$100 or more at the nurseries, so regardless of your neighborhood, its a areat deal.

Planting sites in these target neighborhoods with low tree canopy cover qualify for trees at \$10 each: Athmar Park, Baker, Barnum, Barnum West, Chaffee Park, Clayton, Cole, College View/South Platte, Elyria-Swansea, Five Points, Globeville, Green Valley Ranch, Jefferson Park, Lincoln Park, Montbello, Northeast Park Hill, Overland, Ruby Hill, Skyland, Sun Valley, Valverde, Villa Park, West Colfax, Westwood, and Whittier.

Applications are due February 15th, and if you're approved for trees, they will be available for pick-up on Saturday April 19.

Recently, arborists and forestry experts have expressed concern about Emerald Ash Borer, an insect that has devastated ash tree populations in mid-western cities and was recently discovered in Boulder in September. With 15 percent of Denver's tree cover consisting of ash trees - some 330,000 trees, the detection of this insect in Colorado raises concerns about the health of the city's urban forest.


