

# VOTING MATTER NOVEMBER 11, 2017 INTER-NEIGHBORHOOD COOPERATION, INC. PROPOSED BYLAW CHANGES

During the 2015 INC election, concerns were raised regarding the process of the election. The purpose of this proposed amendment is to enable the process to be better organized and to provide INC registered neighborhood organizations with prior notice of requirements for payment of dues in order to participate in the March 2018 INC election.

#### **CURRENT BYLAWS:**

#### ARTICLE IV - MEMBERSHIP

A. There shall be four (4) classifications of membership: "Member Organization" (MO), "Member Organization Patron", "Associate", and "Associate Patron".

Member Organization(s)" (MO) shall be any Registered Neighborhood Organization RNO) as set forth in Chapter 12, Article III of the Denver Revised Municipal Code that has delivered a complete application form with dues paid in full.

"Member Organization" Patron is any MO as described in Article IV, A. 1 having paid appropriate 'Patron' dues.

"Associate" is any individual, civil group, non-profit group, or government agency having paid the appropriate 'Associate' dues.

"Associate Patron" is any entity from Article IV, A.3 having paid the appropriate 'Patron' dues.

"Associate" and "Associate Patron" shall be non-voting members.

#### B. Dues.

The amount of dues to be paid, by any member category, shall be established by the Board of Directors (BOD) and shall be due and payable annually by January 1, except that dues for a new MO joining after the annual meeting shall be pro-rated on a quarterly basis.

The current rate of dues shall be as quoted in the membership application and published in the newsletter. A grace period, for receipt of MO dues paid in full, shall be given until the start of the annual meeting. Any MO not paid in full by such time shall be dropped from membership and their delegates shall not be eligible to vote or run for offices until such time as the dues are paid in full, thereby reinstating membership.

#### **ARTICLE V – DELEGATION**

- A. The makeup of paid MO members shall be known as the "Delegation".
- B. Delegates.

Any paid MO representatives shall be recognized as a "delegate".

Each MO shall have no more than two (2) delegates, who shall be designated on the MO's annual application. An MO may change delegate designation by submitting a name change in writing to INC prior to the start of a meeting. Each delegate shall have one (1) vote, regardless of how many MOs a delegate represents.

Each delegate's term shall be determined by their MO.

#### **PROPOSED CHANGES:**

#### ARTICLE IV - MEMBERSHIP

There shall be four (4) classifications of membership: "Member Organization" (MO), "Member Organization Patron", "Associate", and Associate Patron'.

"Member Organization(s)" (MO) shall be any Registered Neighborhood Organization(s) as *defined* in Chapter 12, Article III of the Denver Revised *Municipal* Code that has <del>delivered a complete application form with dues paid in full. complied with the provisions of INC Bylaws Article IV, B. Dues.</del>

"Member Organization" Patron is any MO as described in Article IV, A.I having paid appropriate 'Patron' dues.

"Associate" is any individual, civic group, non-profit group, or government agency having paid the appropriate 'Associate' dues.

"Associate Patron" is any entity from Article IV. A.3 having paid the appropriate 'Patron' dues.

"Associate" and "Associate Patron" shall be non-voting members.



### VOTING MATTER NOVEMBER 11, 2017 INTER-NEIGHBORHOOD COOPERATION, INC. PROPOSED BYLAW CHANGES CONTINUED

#### Dues:

The amount of dues to be paid, by any member category, shall be established by the Board of Directors (BOD) and shall be due and payable annually by January 1.7. except that Dues for a new MO joining after the annual meeting shall be pro-rated on an quarterly basis.

The current rate of dues shall be as quoted in the membership application and published in the newsletter. A grace period, for receipt of MO dues, not paid by February 28 of each year, whether for new or renewing membership, shall mean the MO delegate(s) shall not be eligible to vote or run for offices in the annual election. shall be given until the start of the annual meeting. Any MO not paid in full by such time shall be dropped from membership and their delegates shall not be eligible to vote or run for offices until such time as the dues are paid in full, thereby reinstating members.

A renewing MO or new MO submitting dues after February 28 and before the call to order of the annual meeting may be reinstated or added as an MO effective close of business on the calendar day following the annual meeting including full voting rights for their designated delegates.

#### **ARTICLE V - DELEGATION**

The makeup of paid MO members shall be known as the "Delegation". Delegates.

Any paid MO representative, *provided their MO has complied with the provisions of Article* V.B.2 Dues, shall be recognized as a "delegate".

Each MO shall have no more than two (2) delegates, who shall be designated on the MO's annual application. An MO may change delegate designation by submitting a name change in writing to INC prior to the start of a meeting. Each delegate shall have one (1) vote, regardless of how many MOs a delegate represents. Each delegate's term shall be determined by their MO.

### **VOTING MATTER November 11 Resolution to Amend the Zoning Code to Provide Zoning of Parks**

Passed by the Zoning and Planning Committee of the Inter Neighborhood Cooperation on October 28, 2017.

Whereas the City Charter of the City and County of Denver assigns responsibility for land use to City Council; and,

Whereas Denver's 2010 Zoning Code rewrite created a parks and open space zoning category called OS-A and assigned all parkland to the OS-A category; and,

Whereas the 2010 Zoning Code assigned unilateral, blanket responsibility for all use decisions for OS-A to the Executive Director of Parks and Recreation; and,

Whereas the Director of Parks and Recreation is a single individual, appointed by the Mayor, the 2010 Zoning Code has removed parks land use responsibility from the City Council, who are representatives of the neighborhoods' citizens; and,

Whereas the Director of Parks has used this authority to make decisions about park.

Whereas Inter-Neighborhood Cooperation has opposed the assignment of OS-A land use decisions to the Director of Parks and Recreation in the new Zoning Code in a Resolution issued on September 12, 2009;

### It is Resolved by Inter-Neighborhood Cooperation Zoning and Planning:

We request City Council to amend the Zoning Code such that OS-A land is subject to community-inclusive zoning control processes similar to other zoning classifications and under the authority of City Council and commit to take no action in Council to bring forth a bill in this matter until a meaningful community engagement process has been completed.





### **VOTING MATTER November 11 INC's Second Resolution Re: Denver's Acquisition of Park Hill Golf Course**

Whereas, on April 8, 2017, the INC Board of Delegates adopted by a vote of 35 in favor, 3 against, and 7 abstentions a Resolution regarding Park Hill Golf Course that, among other things, called upon the public officials of the City and County of Denver "...to commit to the preservation of Park Hill Golf Course and thereby prevent all or any part of it from being developed other than for park land..."; and

Whereas, since the adoption of that Resolution, the INC Park and Recreation Committee has uncovered the existence and history of a perpetual conservation easement held by Denver that limits use of the property (which is owned in essence by Clayton Early Learning) to open space in general and a golf course in particular, which history can be found on the INC website; and

Whereas, on September 21, 2017, a complicated proposed contract between Denver and Clayton was publicly released (likewise on the INC website) that, among other things, would divide the 155 acres of Park Hill Golf Course into 2 parcels – 50% of the property that would be sold in fee title directly to Denver for \$10 million (Art. 2) and the remaining 50% that would be "leased" to Denver (Art. 3.1) but also subject to potential sale to third parties depending on the outcome of a "Visioning / Master Plan" process (Art. 7); and

Whereas, the proposed contract provides that Clayton would take the lead on the "Visioning / Master Plan" process to determine how much of the golf course could be developed and how dense that development could be (Art. 4.1), while also providing up to \$350,000 in reimbursement to Clayton for the cost of those planning services (Art. 8.1); and

Whereas, the proposed contract also provides that Clayton would receive 75% of proceeds from the sale of golf course land to third parties (Art. 7.4), with the requirement that all such sales be "consistent" with the master plan to be crafted by Clayton and at the then-appraised market value (Art. 7.2 and 7.3); and

Whereas, the result of the above provisions of the contract is to create a conflict of interest in Clayton because on the one hand Clayton would be in charge of the "Visioning / Master Plan" process, yet on the other hand Clayton would then receive revenues based upon the result of that "Visioning / Master Plan" process such that the greater and denser the development approved for the golf course, the more money Clayton would make from sales to third parties.

### Now Therefore, Inter-Neighborhood Cooperation calls upon the public officials of the City and County of Denver

- (1) To amend the proposed contract between Denver and Clayton regarding Park Hill Golf Course so as to remove Clayton from being the lead on the "Visioning / Master Plan" process, and to delete from the proposed contract reimbursement to Clayton for any participation it might choose to undertake in the planning process; and
- (2) To commit to the preservation of the Park Hill Golf Course property as park land and open space.

Vision Zero Action Plan -- David DiGiacomo, Senior Engineer with Dever Public Works Transportation and Mobility Last month, the City released its Vision Zero Action Plan, a five-year plan to achieve zero traffic deaths and serious injuries by 2030. The plan represents significant collaboration among city agencies, state partners, community partners, INC, and other residents. David DiGiacomo, Senior City Engineer, will present the Action Plan's improvements related to processes, street design, safe speeds, a culture of safety, and data/transparency. Vision Zero was part of the INC Transportation Committee Platform and we are thrilled to see the final Action Plan. David will provide an update on the Mayor's 2018 budget and what Vision Zero-related projects you can expect.

How (Else) To Get Around Denver -- Kate Williams, DRMAC Executive Director Have you, or someone you know, ever had to figure out how to get from place to place when their usual options weren't available? Maybe you have to get to and from a medical appointment and need someone to see you safely back into your home. Perhaps your neighbor can no longer drive safely, but wants to remain independent and doesn't know what transportation options are available. Could your older relatives take Lyft or Uber, but they don't think they can without a smartphone? The Denver Regional Mobility and Access Council's newest *Getting There Guide* has just been published, and is a great mobility resource for the region.

DRMAC's motto is "Mobility and Access for All", and Executive Director Kate Williams will be joining us to share copies of the new guide, tell us about their Transportation Information and Assistance Center, and let us know how we can be sure our neighbors know there are options when we need them.

1. Connecting Neighbors to Help Seniors Thrive -- Hilary Lenz, Program Director at A Little Help Our transportation options change as we age, as does our ability to handle some of the tasks necessary around the home. Studies show that living in the comfort of our own homes is the best, and most costeffective, choice for most people as they age, and our neighbors can choose to stay at home with a little help from their friends and neighbors, rather than move to a retirement community. A Little Help, which began as Washington Park Cares in 2005 and has grown to serve five counties throughout Colorado, is a grassroots nonprofit that connects volunteers and seniors for direct services and social engagement. Has your neighborhood always wanted to connect local volunteers with those who need a little help, but didn't have a way to make the connections or the means to coordinate? Hilary Lenz, the Program Director at A Little Help, may have the answer!

Sidewalk Repair - Can We Get There? -- Councilman Paul Kashmann For many years, INC has identified sidewalks as a key weak point in our city's transportation network. With each property owner's costs maximized as they individually try to pursue bids to repair or replace their small sections of this city infrastructure, the result has been poor overall sidewalk condition, inequities between neighborhoods, and an understandable reluctance by city leaders to use enforcement when they know how unlikely it is that individual property owners can have repairs done at a reasonable cost. Councilman Paul Kashmann has made sidewalks a core focus of his first term, and after City Council's Sidewalk Working Group meetings showed good support for addressing this topic, he has been working with the administration to come up with a program that may bring the efficiencies of bidding a larger set of repairs at one time together with a way to work with neighbors having limited financial means. We're delighted that he can join us to preview the program!

# INC DELEGATE MEETING October 14, 2017 RITA BASS TRAUMA CENTER AUDITORIUM

Delegate Count: Thirty-eight (38) delegates present representing 32 RNO members. Quorum present

Meeting was called to order at 9:07 am and adjourned at 11:34am.

#### **Host Introduction**

Our meeting was hosted by Denver Health. Olga Garcia, Community Affairs Manager, with Denver Health and Dr. Robin Wittenstein, CEO, spoke about Denver Health, their mission, and new facility.

#### **COMMITTEE REPORTS**

#### **INC Annual Awards Dinner Committee**

George Mayl provided update on the annual dinner. Help is needed: Three (3) people to stamp invitations and four (4) people for event check in, person(s) to develop dinner program. Non-delegate RNO members are invited to help out. Annual Awards Dinner is 31 January, 2018. There will be no silent auction. Nominations for award recipients are open.

#### **Denver Decides**

Steve Nissen provided update on Denver Decides. School Board debates were broadcast on Channel 8. For videos, visit denver8tv.org . Next Tuesday, 19 October, is the last ballot issue debate. There will be 26 drop off locations around the city, and ~6 voting centers.

#### **Transportation Committee**

Joel Noble provided update on Transportation Committee. Vision Zero Action Plan was published last week to address the sixty-one traffic deaths last year. Plan aims to get us to zero traffic deaths by 2030. Plan is available at <a href="www.denvergov.org/visionzero">www.denvergov.org/visionzero</a>. Next meeting will include discussion on plan with City staff, matching neighborhood volunteers with neighbors in need, medical transportation services, and discussion on sidewalks. Getting There guides will be available for distribution at the next meeting. Please contact Joel if you are interested in getting hard copies. Joel advocated for the Go Bond and encouraged voting in favor of.

#### **ZAP Committee**

Ean Tafoya and Charles Nadler were recommended as the new Co-chairs for the ZAP Committee. Joel made a motion to approve appointments of Ean and Charles. Ernie Diedrich of HUNI seconded. Discussion ensued related to Ean's role with City Council. Several members articulated that Ean worked on behalf of community issues and was an advocate for neighborhoods. It was also requested that differing viewpoints be respected. The delegates voted 33 in favor, 0 oppose, and 1 abstention.

#### **PARC**

Maggie Price gave report on PARC. Last meeting was 19 September, and Debbie Ortega was in attendance. Park Hill lot at 28th and Fairfax was on list of land that could be designated as a park. Now, it might be sold to a developer. Discussion will happen today at Park Hill Community Center.

#### **Park Hill Golf Course Discussion**

Evan Dryer from the Mayor's Office and Charlotte Brantley, CEO, Clayton Early Learning gave a presentation on Park Hill Golf Course. The Clayton Early Learning center golf lease expires in 2018. Clayton receives \$700/yr from golf operator and does not expect lease to be renewed. Clayton began holding stakeholder meetings in November of 2016 and formed Citizens' Advisory Committee to balance need for income and what community wants to see in that space.

Survey was conducted and top choices for space use were park and open space, mixed used, grocery store, affordable housing. Clayton will continue to work with community on visioning process.

City acquires 50% of property for \$10M on 2 January 2018 and begins construction detention area. Other half of property will be acquired through lease-to-own. Agreement with City allows for open space, full development, or a mix of open space and community serving uses.

Development of land would go through public process and Council approval. Next steps in visioning process includes case studies, additional meetings and forums, and beginning master plan process in March of 2018.

Brad Cameron spoke as a PARC member and a resident. He does not support this plan because it is a bad deal for the city and will not result in a positive outcome for any of the options presented. Current agreement does not reflect existing easement and appraisal reflects removal of easement. There is nothing in the agreement that promotes a grocery store or affordable housing.

Denver Community Planning and Development staff clarified that before rezoning would occur, the City would conduct a neighborhood planning initiative.

CPD will partner with Clayton and lead a typical planning process that will result in a master plan. The City legal representative stated that the conservation easement is only for golf course use and would have to be re-visited unless a golf course is kept there.

Brad Cameron disagreed with this interpretation of the conservation easement. It was asked if the initial \$10M is coming from CDOT, and the City clarified that it is coming from existing city fee revenue.



#### **INC October Meeting Notes Continued**

#### **GO Bond Initiatives**

Evan Dryer, Deputy Chief of Staff, City of Denver discussed GO Bond Measure 2A – 2G. Public input process began with 4000+ projects. Projects were reviewed and prioritized. Mayor's office provided recommendations to City Council, which passed package unanimously. Voters will consider the \$973M of proposals on the November 7 ballot. #### **Green Roof Initiative (I-300)**

Presentation by Nam Henderson.

A green roof is a form of green infrastructure with multiple benefits. Green rooftops provides energy cost savings, urban wild life habitat, amenities for community, to name a few. The initiative would require buildings great than 25,000 square feet to have a garden, solar panel, or other green roof component. Mayor's office has concern with mandate requirement.

- A yes vote is a vote in favor of requiring any new roofing for a building with more than 25,000 square feet of area to cover between 20 % and 60 % of available roof space with vegetation or a combination of vegetation and solar panels—with larger buildings requiring a larger percentage of green/solar coverage—according to minimum standards contained within the initiative.
- A no vote is a vote <u>against</u> requiring any new roofing for a building with more than 25,000 square feet of area to cover between 20 % and 60 % of available roof space with vegetation or a combination of vegetation and solar panels—with larger buildings requiring a larger percentage of green/solar coverage—according to minimum standards contained within the initiative.
