Denver Decides will conduct forums for the two (2) ballot initiatives and four (4) seats on the Denver Public School Board. Forums will be telecast live on Denver 8TV as scheduled below.

#### **Ballot Initiatives:**

#### **Green Roofs Initiative**

\$937 Million Bond Package (voters will cast seven (7) yes or no votes for the bond package items. They are as follows.)

- 1. \$431 million for transportation and mobility projects, including road and bridge repairs and repaving, new bike lanes and pedestrian projects.
- 2. \$151.6 million for parks and recreational projects.
- 3. \$116.9 million for cultural facility projects, including at the Denver Zoo, the Denver Botanic Gardens, the Denver Museum of Nature & Denver Art Museum.
- 4. \$77 million for public-safety related projects, including for police and fire Stations.
- 5. \$75 million to cover about half of the cost of the Denver Health and Hospital Authority's planned outpatient Ambulatory Care Center.
- \$69.3 million for library renovations, including at several branches across the city.
- 7. \$16.5 million for public facilities.

#### PERSON OF THE YEAR (Virginia Oredson Award):

The Virginia Oredson Award is given to a person who:

- Has encouraged Denver neighborhoods or citizens to work together in a common effort to solve community problems.
- Has established a record of selfless community service and has encouraged and motivated others to volunteer their services to engage in community improvement.

PUBLIC SAFETY (Bill Gross Award): The Bill Gross

Award is given to a person who:

- Has a strong record of working with neighborhoods to better public safety in the community.
- Has made Denver a safer place in which to live.

#### **OUTSTANDING INC DELEGATE (Walt Kembel Award):**

The Walt Kembel Award is given to a person or group who:

- Is an INC delegate or a member of a member RNO.
- Has contributed to INC during the past year over and above normal expectations to develop and promote the organization, or has moved INC forward or in new directions in creative or unexpected ways.

**Neighborhood Stars:** Neighborhood Stars are nominated for that award by the Board of an INC member RNO.

A Neighborhood Star is awarded to a person who has:

 A person who has made a difference in their Neighborhood. Worked individually or with a group to make "Denver a Better Place to Live".

• Worked individually or with a group over the past year on a cause or a project that has improved the appearance or the quality of life in their neighborhood.

The panelists included: Luchia Brown, moderator, Dennis Royer, PE; Bill DeGroot, PE, F.ASCE, Albert Melcher, MS civil engineer; John VanSciver, PE; Patty Ortiz, PE, PMP Andrea Gelfuso, Esq, and Kyle Zeppelin, developer.

INC's monthly meeting was held at Manual High School on Saturday September 9. INC appreciated DPS allowing us to meet in this lovely school. About 100 people attended the meeting.

In lieu of a regular meeting, INC held a public forum to discuss CDOT's planned expansion of I-70 through the neighborhoods of Elyria and Swansea, and the City of Denver's related Platte to Park Hill Storm Water Project. Over 100 people attended the event. CDOT and Denver's City Planning were invited to be on the panel and both declined.

INC's goal was to provide an opportunity to have a serious open discussion about these two very complicated and controversial projects as well as ask hard questions that many feel have not been answered.

Although INC invited representatives from the City of Denver and CDOT to participate, they declined. Because many of the concerns and questions need to also be answered by the City and CDOT, INC has requested Denver and CDOT officials provide answers and when received, INC believes this further input will help satisfy expressed concerns, especially about health impacts.

As a result of the forum, delegates (members) from INC passed the following Resolution:

 INC neighborhoods oppose the proposed expansion of I70 because it increases the health impacts on our neighborhoods and we call on Governor Hickenlooper and Mayor Hancock to halt the project until all health impacts have been eliminated.

The Resolution passed by an overwhelming majority vote. This Resolution has been sent to the Governor, Denver's Mayor, members of Denver City Council, and CDOT officials.

The quorum remaining after the forum also approved Board positions Jo Barrios as Secretary and Loretta Koehler as Delegate-at-Large and approved minutes from the delegate meeting held August 12.

## Who can vote at INC meetings?

INC hosts monthly meetings on the second Saturday of every month. Any paid RNO member organization representative shall be recognized as a "Voting Delegate".

Per Bylaws: Each Member Organization (RNO level) shall have no more than two (2) voting delegates, who shall be designated on the annual membership application. Each attending delegate shall have only one (1) vote, regardless of how many member RNO's a delegate represents.

#### **Rotating Delegate Option**

We know you are busy so, RNO members can also designate alternating/rotating voting delegates to attend INC's meetings. This means that if your "regular" delegate cannot attend all meetings, your RNO can send a substitute of choice to represent your neighborhood. The "in writing prior to the start of a meeting" includes email notices or when you sign in upon arrival. We hope this makes it easier for your RNO to be represented more often at our meetings.
